

## **FERNDALDE BOROUGH**

Regular Meeting

October 9, 2025

The Ferndale Borough Council met on Thursday, October 9, 2025, in the Fireman's Recreation Hall at 618 Westinghouse Avenue, Johnstown, PA.

President Owen Hofecker called the meeting to order at 6:00 P.M. Those present recited the Pledge of Allegiance to the U.S. Flag.

### **ROLL CALL**

### **MAYOR AND POLICE REPORTS**

Mayor Ralph Boyle read a letter of resignation from Nathan Kniss. A motion was made by Connie Hobbs to accept Officer Kniss resignation and payment to end his contract with Ferndale Borough, seconded by Eric Baumbaugh. The motion carried.

Resolution #4 was presented Reducing Police Officer Contributions to the Police Pension Plan for 2026. A motion to pass the resolution was made by Cindy Dom seconded by Zachary Neal. A roll call vote was taken with all present members voting yes. The motion carried.

Mayor Ralph Boyle said that 850 was at Laurel Ford for warranty work but is now back.

### **FERNDALE FIREMAN'S ASSOC. REPORT**

Mayor Ralph Boyle said invitations went out for the jubilee banquet to anyone who worked three or more days.

### **STREETS AND PROPERTY**

Eric Baumbaugh said Penelec has been in the borough running new lines.

Nancy said the leaf machine has been sold on municipal bid site. We are waiting for the individual to come from Ohio to pick it up. She has mailed out late garbage notices and posted properties for water termination for non-sewer payment.

### **TREES**

Zachary Neal said he is still working on talking to the resident on Vickroy Ave where the tree went down.

### **SEWER/SEWER PROJECT REPORT**

Frank DiLoreto was present from EADS.

Two pressure tests were completed in September.

Ferndale Ave Sidewalk Rehabilitation Project: Construction started on 9/22/2025. Construction is substantially complete. EADS coordinated with PennDOT on a detail to repair the existing curb. The curb pinning detail information was sent to Kishmo to prepare a quote for the work. EADS is going to contact contractors about trimming the existing trees.

Station St Phase 2 Project: Construction started 8/18/25. Final inspection was completed on 10/7/2025. The project can be closed out once all the reimbursements are completed.

DCED LSA 2024 Grant: Grant announcement is delayed until there is an approved budget. Once the budget is approved, they will meet to determine the projects receiving funds.

DCED MTF 2025 Grant: An application was submitted for the sidewalk between Vickroy and Ferndale Avenue. A grant announcement date has not been determined at this time.

DCED LSA 2025 Grant: Projects between \$25,000-\$1,000,00. Applications are accepted from September 1, 2025 – November 30, 2025.

### **TAX COLLECTOR'S REPORT**

Tax Collector's Report was presented for September 2025. The amount collected in September was \$362.63.

### **FINANCE/ACCOUNTS PAYABLE**

A motion to pay all Accounts Payable was made by the committee, seconded by Cindy Dom. The motion carried.
